Pokhariya Municipality invites sealed bids or electronic bids from eligible bidders for the
construction of Kamal Mukhiya ko Ghar Dekhi Nahar hudai kalopatrai, Laxman Singh ko ghar
dekhi Radha krishna mandir kalopatrai, Masjid dekhi Slab culvert and Mansur Miya ko ghar
dekhi nahar hudai Gravel Road (ward no-05, Parsa) under National Competitive Bidding –
Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs 3,63,00,000.00
- Minimum Work experience of similar size and nature: NRs 97,00,000.00
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Pokhariya Municipality* or may visit PPMO e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>.
- 4. Bidder who chooses to submit their bid electronically may download the bidding documents for esubmission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and upon payment of a non-refundable fee of 5000 till 19-05-2025 12:00 during office hours.

- 6. electronic bids must be submitted through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> or 19-05-2025 12:00. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 19-05-2025 14:00 at the office of Pokhariya Municipality, Parsa. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of 7,20,000, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
